Municipal Works Australia Conference - March 2024

The 30th Municipal Works and Engineering conference was held in Bendigo in late March, Over 720 delegates filled the Prince of Wales Exhibition Centre, Some three dozen, suppliers filled the exhibition centre.  Road sHVs More Often Involved In Level Crossing Collisions

A study by the Australian Transport Safety Bureau has found heavy vehicles are more frequently involved in level crossing collisions than cars and other light vehicles.

The study, released ahead of the national rail level crossing safety roundtable on Wednesday, March 6, set out to compare the severity of level crossing collisions involving heavy road vehicles, to those involving light road vehicles, ATSB Chief Commissioner Angus Mitchell explains.

The research, detailed in the final report, used qualitative and quantitative methods to analyse data from both Australia and the United States, including a review of all reported level crossing collisions involving heavy vehicles in Australia from July 2014 to August 2022.

Work gathers pace on Oxford Street west cycleway project

City of Sydney

Sydney's busiest bike route is closer to having a separated cycleway with construction works on the Oxford and Liverpool Street project now underway.

Once complete, the nearly 1km long cycleway will give thousands of daily riders a two-way link between the city and the eastern suburbs, greatly improving the safety and enjoyment of riding.

The City of Sydney's Oxford Street west project involves construction between Castlereagh Street and Taylor Square, while the state government's Oxford Street east project will be built between Taylor Square and Paddington Cates.


Vulnerable road users: Facts and figures

Construction Truck Operating Cost increases

Construction truck operating costs, averaged over four truck types: concrete agitators, low loaders, flattop semi-trailers, and rigid truck and dog tippers are presented in Table 1.

Construction Truck Operating Cost increases		
	Total Change	Per annum change
5 years	23.6%	4.3%
3 years	24.1%	7.4%
1 year	4.3%	4.3%

Urban construction truck costs are pressured by labour and fuel prices, longer distance regional operating costs are more fuel dependent. Fuel costs declined slightly over the last year keeping costs lower than the 3 year per annum increases which were impacted by the large diesel increases throughout 2022. Companies have also incurred high national wage case award increases over the last 3 years. It is important that construction fleets have appropriate contract escalation clauses in place to offset cost increases.
